- 6. The terms of this agreement are however, subject to revision/ modification after a period of 12 months, every year.
- 7. During the term of Affiliation college expect cooperation from hospital for inspection purpose in terms of necessary documentation (such as hospital registration certificate from pollution control Board and IPD, OPD numbers).
- 8. This Agreement can be terminated by either party, by giving 45 days' notice in writing or proportionate amount in lieu thereof.


